#### Introduction

High Cal Games LLC ("We" or "us") administers the following website: https://www.highcalgames.com(the "Site").

We respect your privacy and are committed to protecting it through our compliance with this policy. This policy describes:

- The types of information that we may collect or that you may provide us when you use the Site; and
- Our practices for using, maintaining, protecting, disclosing and otherwise processing that information.

This policy applies only to information that we collect on or through the Site and in electronic communications sent through or in connection with the Site.

This policy DOES NOT apply to:

- Other information that you provide to third parties,
- Information that we collect through other websites,
- Information that we collect offline, or
- You provide to or is collected by any third party (see Third-Party Information Collection).

The Site contains links to third-party websites, products or services. The Site may also display content from third parties. Information collected by third parties is governed by those third parties 'privacy policies. We encourage you to read these before providing information on or through them.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, do not access, register with, or use the Site. By accessing, registering with, or using the Site you agree to this privacy policy. This policy may change from time to time (see Changes to Our Privacy Policy). Your continued use of this Site after we revise this policy means you accept those changes, so please check the policy periodically for updates.

# Children Under the Age of 13

The Site is not intended for children under 13 years of age, and we do not knowingly collect personal information from children under 13. If we learn we have collected or received personal information from a child under 13

### Information We Collect and How We Collect It

We collect several types of information from and about users of our Site, from two sources:

- You, either directly when provide it to us or automatically when you use our Site; and
- Third parties.

# Information You Provide to Us Directly

When using our Site, you may provide us with certain types of information which may include, information:

- By which you may be personally identified, such as name, postal address, email address, phone number or any other identifier by which you may be contacted online or offline ("personal information").
- About your internet connection, web browser, the equipment you use to access our Site, and usage details.

#### This information includes:

- Information you provide when you subscribe to our newsletter.
- Records and copies of your correspondence (including email addresses and phone numbers), if you
  contact us.

# Information Collected Automatically When You Use Our Services

When you access and use the Site it may use technology to automatically collect:

- Usage Details. When you access and use the Site, we may automatically collect certain details of your access to and use of the Site including traffic data, location data, logs, and other communication data and the resources that you access and use on or through the Site.
- Device Information. We may collect information about your mobile device and internet connection, including the device's unique device identifier, IP address, operating system, browser type, mobile network information, and the device's telephone number.

### **Do Not Track Disclosure**

The Site does not support "Do Not Track" browser settings and do not currently participate in any "Do Not Track" framework that would enable us to respond to Do Not Track signals.

# **Information Collection Technologies**

Like most websites, we may use small data files that are saved on the user's computer, tablet, mobile phone or other mobile device (collectively referred to as "device") to record certain data each time a user logs in or interacts with our websites, services, apps, messaging systems and tools. The names and the specific types of cookies, web beacons and other similar technologies that are used can change over time. To help you better understand the policy and use of these technologies, here are some terms with their definitions:

**Cookie:** A cookie is a small file placed on the hard drive of your computer or on you mobile device. Cookies allow a website to recognize a particular device or browser. You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Site. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Site.

**Web beacon:** small images, also known as "pixel tags" or "clear GIFs", which we may include in our websites, services, apps, messages, and tools. Generally, they work with cookies to identify our users and their activities. Similar technologies: technologies that store data in the browser or device using objects shared or stored locally, such as flash cookies, HTML 5 cookies and other software methods for web applications. These technologies work

in all browsers. In some cases, the use of local storage cannot be fully handled by the browser but needs to be managed with special tools. We do not use these technologies to store information useful for creating targeted advertising on our or other websites. However, certain features of our Site may use these technologies to collect and store information about your preferences and navigation to, from, and on our Site. Flash cookies are not managed by the same browser settings as are used for browser cookies. For information about managing your privacy and security settings for Flash cookies, see Your Rights and Choices.

### **How We Use Your Information**

We use the information that we collect about you or that you provide to us, including any personal information, to:

- To provide, support, maintain, personalize, develop and improve our Site and services.
- To fulfill or meet the reason you provided the information. For example, if you share your name and
  contact information to request information about one of our products, we will use that personal
  information to respond to your inquiry. We may also save your information to facilitate new product
  orders or process returns.
- To provide subscribers with information about our services.
- Records and copies of your correspondence (including email addresses and phone numbers), if you
  contact us.
- For testing, research, analysis, and product development, including to develop and improve our Site, products, and services.
- To comply with legal obligations, and to respond to legal process or inquiries from authorities.
- For any reason that we described to you when collecting your personal information or for any reason for which you've provided us with your consent.
- To protect the rights, interests, and safety of us, you, and any third parties, and to exercise and defend our rights.
- To create anonymous, de-identified, or aggregated datasets. Such datasets would not be "Personal Information" subject to this Privacy Policy. We may use anonymous, de-identified, or aggregated datasets for any purpose.
- To evaluate or conduct a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which user personal information is among the assets being transferred.

The usage information we collect helps us to improve our Site and services and to deliver a better and more personalized experience by enabling us to:

- Estimate our audience size, demographics and usage patterns.
- Store information about your preferences, allowing us to customize our Site and services according to your individual interests.
- Recognize you when you use the Site.
- Prevent fraud and illegal behavior by detecting behavior patterns that indicate such activity.

### **Disclosure of Your Information**

We may disclose aggregated information about our users, and information that does not identify any individual or device without restriction.

In addition, we may disclose personal information that we collect, or you provide:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of High Cal Games LLC's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by High Cal Games LLC about our Site users is among the assets transferred.
- To fulfill the purpose for which you provide it.

- For any other purpose disclosed by us when you provide the information.
- With your consent.
- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of High Cal Games LLC, our customers or others.

# Where, How and How Long We Store Your Information

We encrypt all collected information and stores it securely in the United States using third-party vendors and hosting partners who implement industry standard security measures. By using the Site, you authorize us to transfer, store and process your information in the United States.

We keep your information only for the length of time necessary to fulfill the purposes for which the information was collected. If applicable laws require us to store your information for a longer period, then we will keep your information for the period required by law. When it is no longer necessary or required for us to retain your data, we will delete it.

# **Your Rights and Choices**

The Site is intended only for residents of the United States.
